
Description of this Fund

The Australasian Equity Fund invests in Australasian equities primarily listed on the New Zealand equity market. It aims to provide a gross return in excess of its benchmark index, over the long term.

What are the risks of investing?

Risk indicator¹ for the Australasian Equity Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down (volatility). A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the Fund performed?

Example of how this applies to an investor


John had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, John received a return after Fund charges were deducted of \$1,177.00 (that is 11.77% of his initial \$10,000). John also paid \$0.00 in other charges. This gives John a total return of \$1,177.00 for the year.

Notes
